- a. That a candidates fee of 5% of the Annual Salary of an Ordinary Councillor within the specific municipality elected, will be paid over a period of 6 months, towards the election costs. This will proportioned against the remaining period of time in the term of office.

- c. That should the Candidates fees not be settled within the 6 month period my membership of GOOD could be terminated and I could lose my seat in council.
- d. That I will be required to tithe 2.5% per month of my monthly salary to the movement from a date after my election.
